CORRECTIVE DEPENDENT RESURVEY

SURVEY INFORMATION AND CERTIFICATE

This plat represents the entire record of the corrective dependent resurvey of the metes and bounds survey of Tract 89, correcting the numbering sequence from 84 to 89.

The history of earlier surveys pertaining to this corrective dependent resurvey is as follows:




William H. Proctor surveyed the subdivisinal lines in 1883. The survey was subsequently cancelled. William R. Bandy, under joint contract with Arthur H. Brunt, surveyed the private land claims and resurveyed the subdivisinal lines in 1907. William H. Bandy surveyed, segregated, amended and eliminated certain tracts in 1911. Thomas E. Casinger dependently resurveyed a portion of Tract 81, and a portion of the subdivisinal lines, and surveyed the erroneously numbered Tract 84 in 1992.

This corrective dependent resurvey as shown hereon, corrects the 1992 erroneously numbered metes and bounds survey of Tract 84 to Tract 89. The corner positions and the bearings and distances are not affected, and their descriptions remain the same as described by the 1992 plat and field notes. The brass cap markings were corrected in the field and are marked as shown hereon.

The area embraced by this corrective dependent resurvey is situated in the southeast portion of Park County approximately 2 miles northeast of Meeteetse, Wyoming, along southern right-of-way of Wyoming State Highway No. 30.

I, Joel T. Ebner, Cadastral Surveyor, HEREBY CERTIFY upon honor, that in pursuance to Special Instructions dated November 12, 2002, and Assignment Instructions dated November 12, 2002, for Group Number 709, Wyoming, I have corrected the metes and bounds survey of erroneously numbered Tract 84 to Tract 89, Township 50 North, Range 99 West, Sixth Principal Meridian, Wyoming, and that this plat in one sheet represents the entire record of the survey. Field corrections executed December 11, 2002, and has been made in strict conformity with the special instructions, the Manual of Surveying Instructions for the Survey of the Public Lands of the United States, 1973, and the specific manner described hereon.
