
DEPENDENT RESURVEY AND SURVEY OF RIPARIAN LANDS



A history of surveys is contained in the field notes.

This plat, in 2 sheets, represents the dependent resurvey of a portion of the Fourteenth Auxiliary Meridian West, through T. 40 N., between Rs. 116 and 117 W., and a portion of the subdivisional lines designed to restore the corners in their true original locations according to the best available evidence, the subdivision of sections 14 and 25, the survey of portions of the present right bank of the Snake River, the riparian partition lines, and the metes and bounds survey of Lot 15, section 25, T. 40 N., R. 117 W., Sixth Principal Meridian, Wyoming.

Except as indicated hereon, the lottings and areas are as shown on the plat approved April 2, 1903.
