



TOWNSHIPS 50 & 51 NORTH, RANGE 73 WEST, OF THE SIXTH PRINCIPAL MERIDIAN, WYOMING.

CORRECTIVE DEPENDENT RESURVEY



SURVEY INFORMATION AND CERTIFICATE

This plat represents the entire record of the corrective dependent resurvey of a portion of the line between Townships 50 and 51 North, Range 73 West, designed to restore the corners in their true original locations according to the best available evidence.

The history of earlier surveys pertaining to this resurvey is as follows:

Louis F. Stahle surveyed the township line in 1883. Joe R. Salazar dependently resurveyed the township line in 1990-91, during the dependent resurvey of T. 51 N., R. 73 W.

John Dolinar, Wyoming Registered Land Surveyor No. 2608, purported the bearings and distances of the mile between secs. 6 and 31, Tps. 50 and 51 N., R. 73 W., did not conform to the official record, by a substantial amount. A field investigation substantiated the purported findings, and confirmed errors in measurements. This corrective dependent resurvey as shown hereon, corrects the measurements between sections 6 and 31, and the areas of the lots. The corner positions were not affected, and are described in the field notes of the 1990-91 dependent resurvey of the south boundary, T. 51 N., R. 73 W.

The survey was executed with a Trimble global positioning system (GPS) model 4700 real time kinematic receivers. The direction of all lines referring to the true meridian and the distances were determined by GPS methods. The geographic position was determined from existing resurvey data.

The area embraced by this survey is situated in the central portion of Campbell County, approximately 10 miles northwest of Gillette, Wyoming. Access is provided by county roads and trails.

I, Joel T. Ebner, Cadastral Surveyor, HEREBY CERTIFY upon honor, that in pursuance of Special Instructions dated April 25, 2001, and Assignment Instructions dated April 25, 2001, for Group Number 692, Wyoming, I have corrected the dependent resurvey of a portion of the line between Townships 50 and 51 North, Range 73 West, Sixth Principal Meridian, Wyoming, and that this plat in one sheet represents the entire record of this survey. Field assistant was Tyrel S. Hoon, Surveying Technician. Survey executed April 30, 2001, and has been made in strict conformity with the special instructions, the Manual of Surveying Instructions for the Survey of the Public Lands of the United States, 1973, and in the specific manner described hereon.
