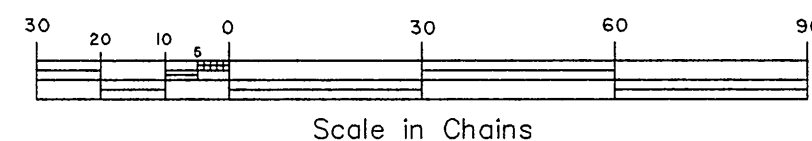
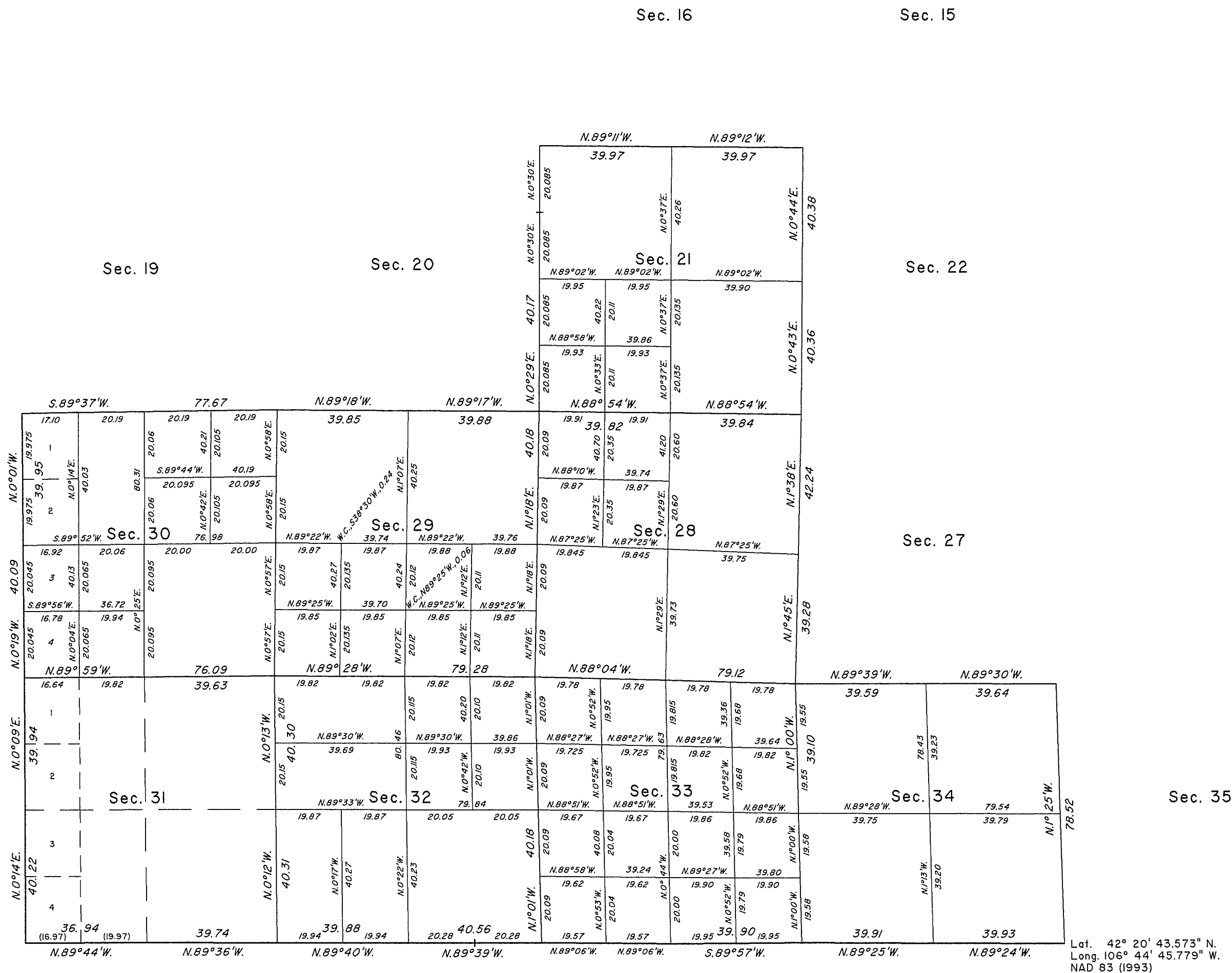
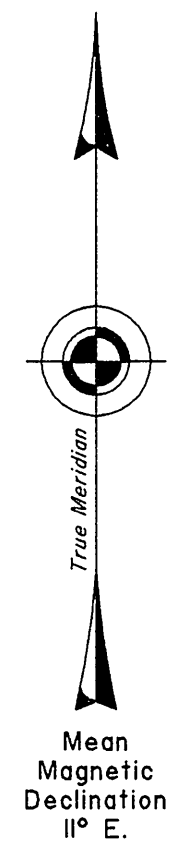

DEPENDENT RESURVEY AND SUBDIVISION OF CERTAIN SECTIONS



A history of surveys is contained in the field notes.

A portion of the south boundary was dependently resurveyed by Lynn A. Forbes during the dependent resurvey of T. 27 N., R. 83 W., executed concurrently under this same group.

This plat represents the dependent resurvey of a portion of the west boundary and a portion of the subdivisional lines, designed to restore the corners in their true original locations according to the best available evidence, and the subdivision of certain sections, T. 28 N., R. 83 W., Sixth Principal Meridian, Wyoming.

Except as indicated hereon, the lottings and areas are as shown on the plat approved April 16, 1884.

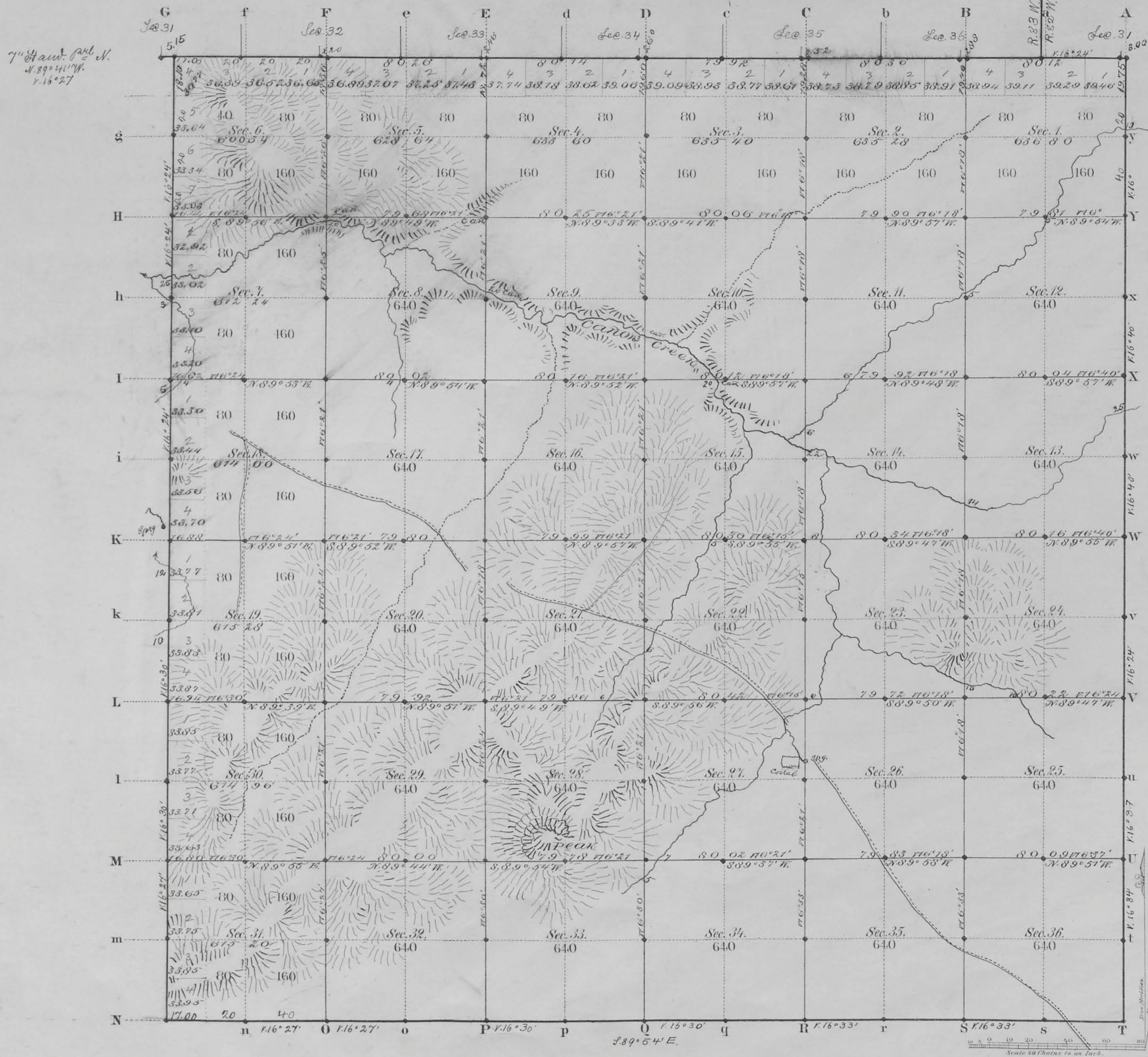

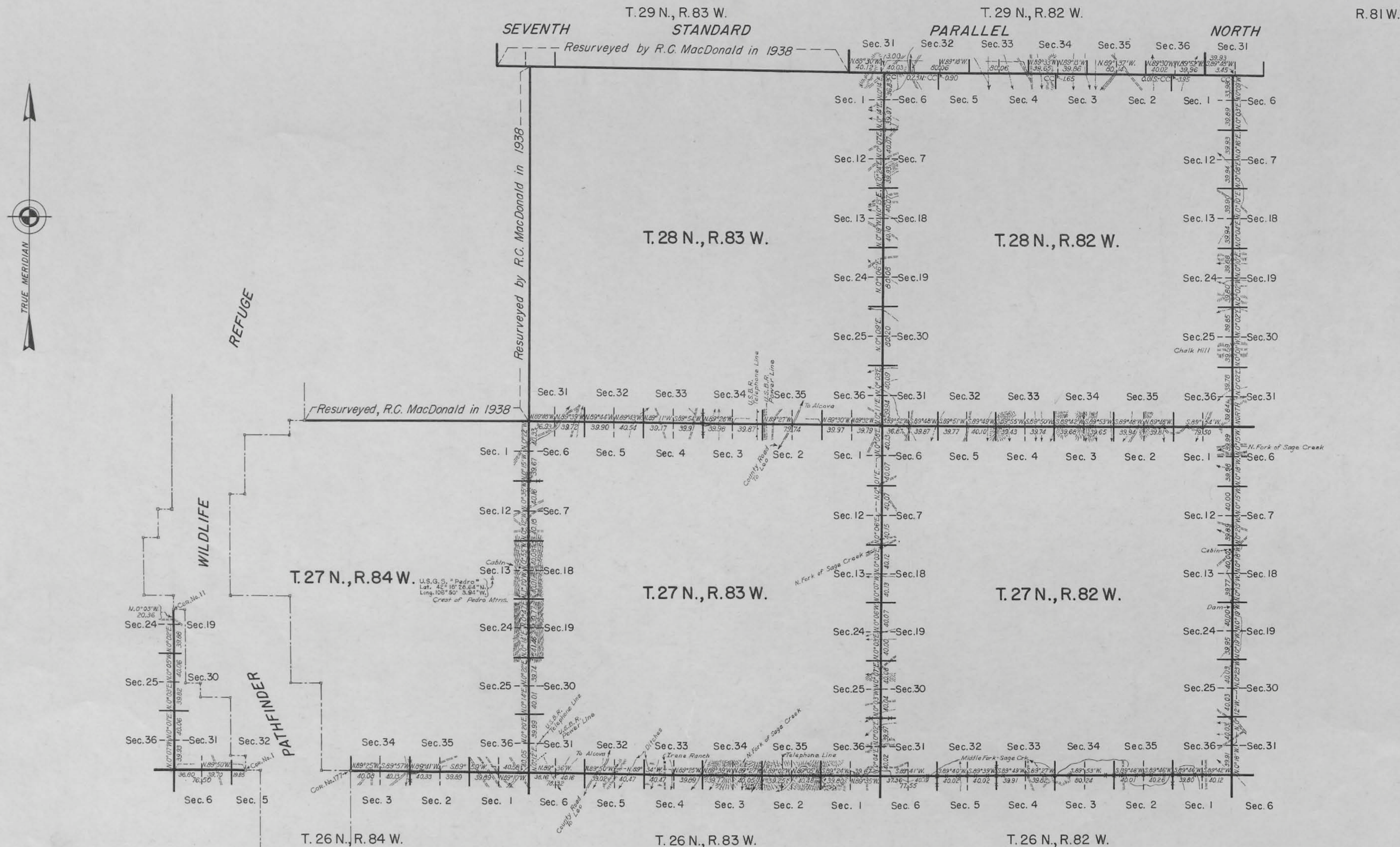

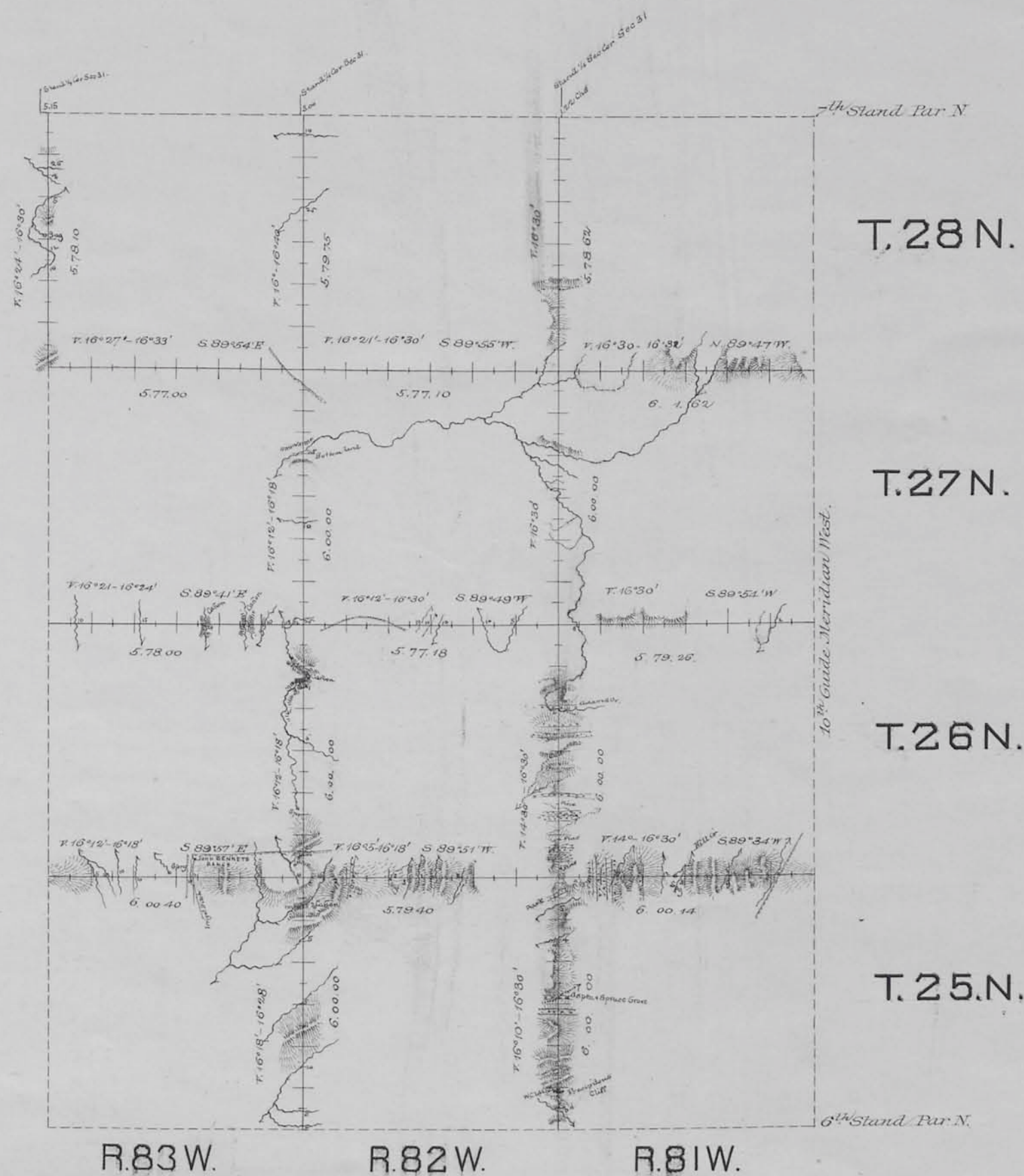
