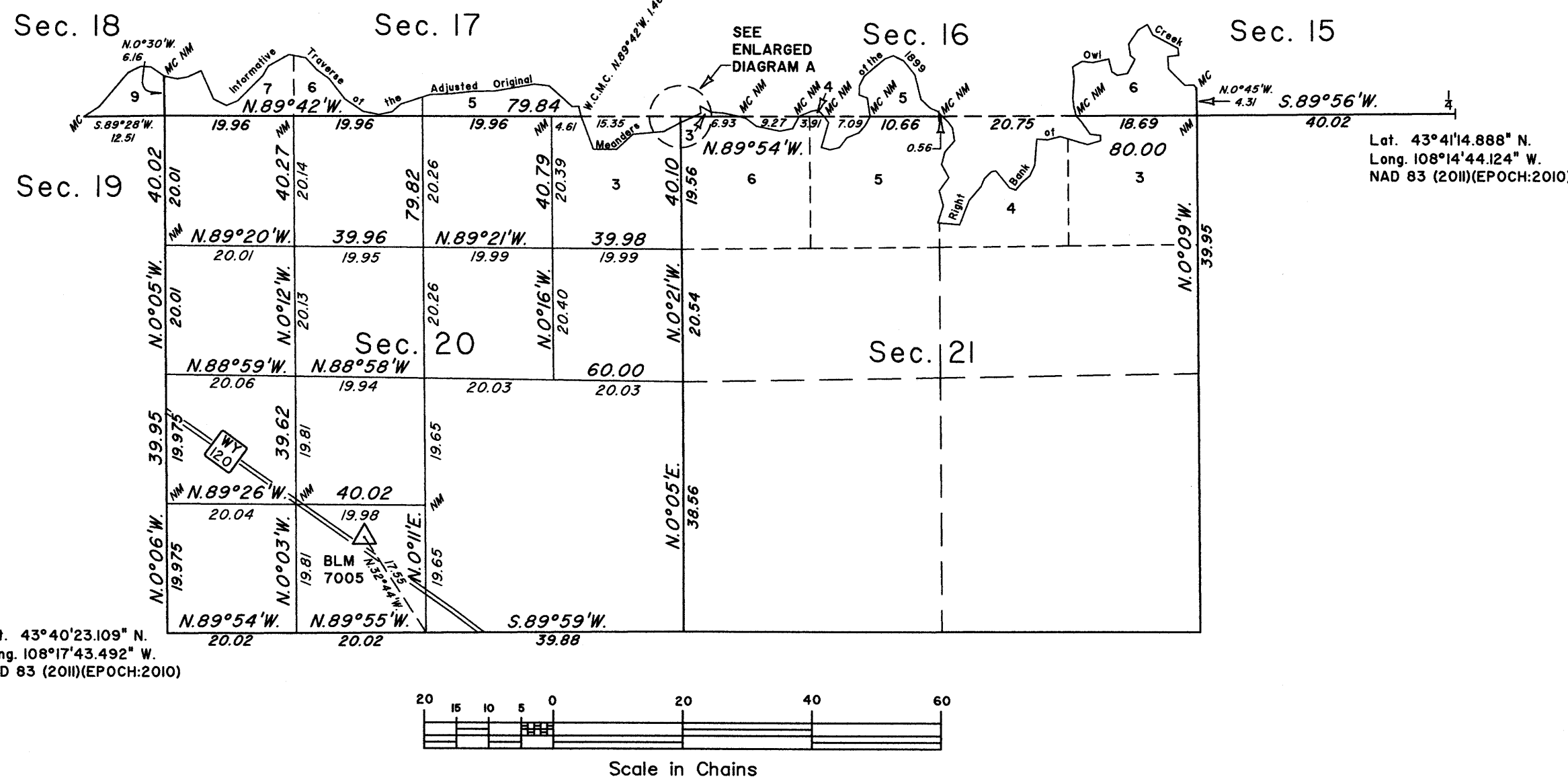

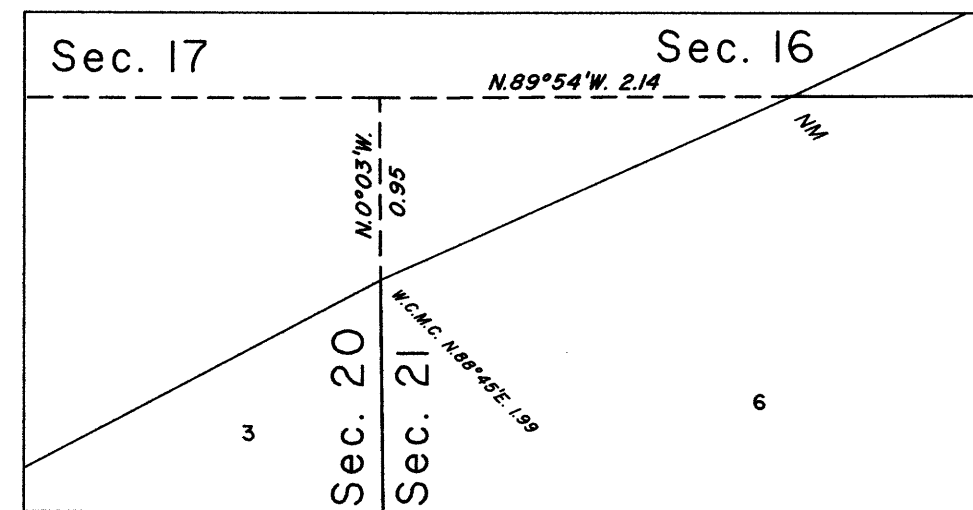
This plat represents the retracement and dependent resurvey of a portion of the subdivisional lines, designed to restore the corners in their true original locations according to the best available evidence, the survey of the subdivision of fractional section 20, and the informative traverse of the adjusted original meanders of the 1899 right bank of Owl Creek through fractional sections 16, 17, 18, 20 and 21, fractional T. 43 N., R. 95 W., Sixth Principal Meridian, Wyoming.

Except as indicated hereon, the lotting and areas are as shown on the plat approved April 28, 1900.

Survey executed by James R. Gampetro, Cadastral Surveyor, beginning March 8, 2021, and completed May 20, 2021, pursuant to special instructions and assignment instructions dated February 23, 2021, for Group No. 1033, Wyoming.

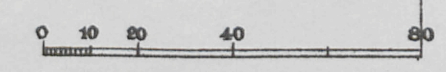

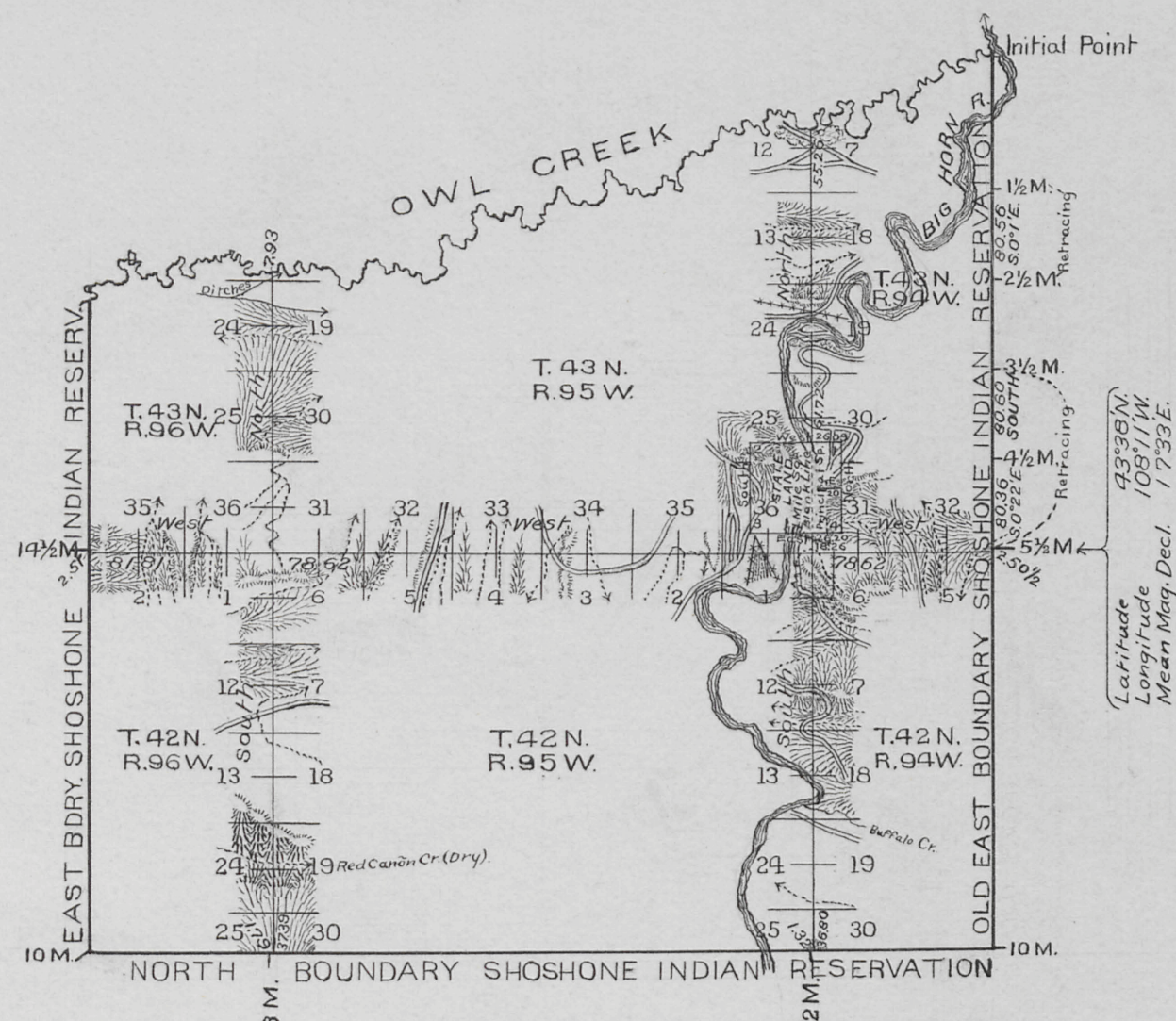

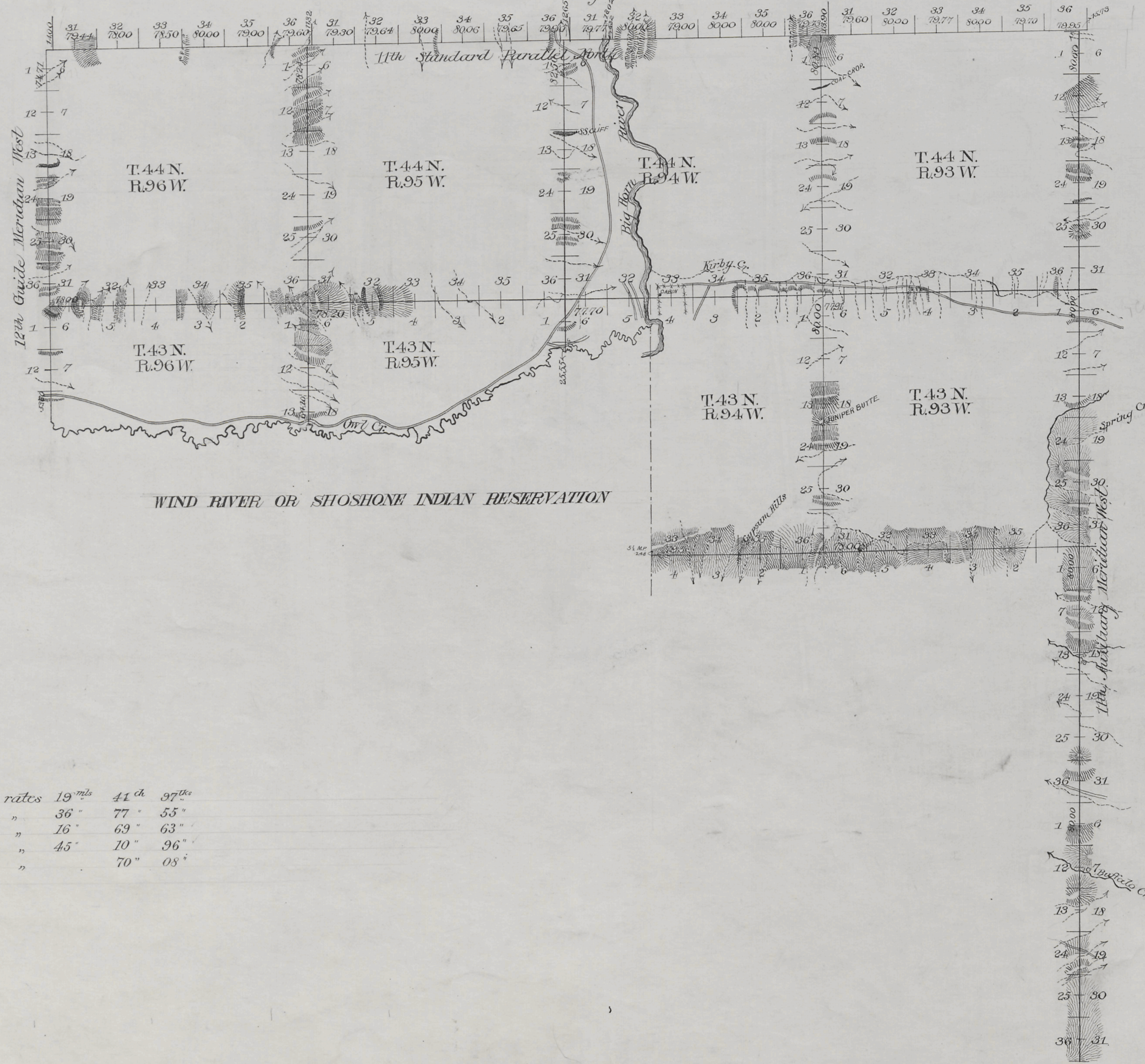
