CBM Clearinghouse

Want to combine MT-WY CBNG data so that it is geographically displayed and can zoom in/out.

Can all types/agencies data be integrated into shapfiles?

- It can, however consistent data standards would need to be developed, and funding provided to create and update the shape files.
- BLM-WY SO is working to get similar information together. Working with Rick Marvel (WY-O&G) to get data dumps now.
- Paul Beels will check on the data that Rick is getting together

We will need to make the format of data part of the monitoring plans that we develop. The database parameters will need to be set Need to develop work plans and monitoring plans with costs figured out and completion dates set.

Data sources/Information:

- NPDES monitoring reports (MT and WY DEQs)
- Regional USGS Monitoring Data
- Head and Water Quality information from deep wells (bedrock) (MT&WY-BLM; Northern Cheyenne)
 - Northern Cheyenne info is currently in the USGS website (http://waterdata.usgs.gov/mt/nwis/gwsi)
- Infiltration Basin Monitoring
 - On and Off Channel
 - Flumes to determine conveyance loss

Monitoring Plans will need to address monitoring reports for evaluation of the data collected.

Andy Bobst requested that a summary the monitoring being conducted by all agencies be sent to him to collate.

Need to get State O&G and Engineers Offices involved.

Monitoring Plans should be broken out by watershed and by scale.

These are my interpretation of examples about what we discussed (ALB)

 i.e. Tongue River Regional Surface Water Monitoring Plan Infiltration Basin Monitoring Plan Powder River Regional Surface Water Monitoring Plan MT-WY Powder River Basin Bedrock Groundwater Monitoring Plan Tongue River Alluvium Monitoring Plan Powder River Alluvium Monitoring Plan Rosebud Creek Surface Water Monitoring Plan (MT only) Ect.

Need to develop the monitoring plans with a description of the type of information to be collected on a site specific basis. Also consider 4^{th} and 5^{th} order watersheds.

Use the EIS setup as a template for the monitoring plans: Major Tribs...

Andy Bobst will put together an outline of what the monitoring plans will look like. Probably will start with Tongue River Surface Water Monitoring Plan.

Resolving Permitting problems

We should request the IAWG to add a task to the Hydro Working Group to "Serve as a forum for the resolution of permitting/process related problems."
