- Anna Senecal (UW) field work done this summer -thesis by May 2009. Found 4 sturgeon chub upstream of Crazy Woman Creek on Powder River.
- Aida (USGS) presented latest findings. The group decided we wanted to include all data and wait for the final report, which could then be used to develop water quality standards for HCO3. This report would be late summer or fall 2009. Some discussion of standards and who should/would set them. The group's decision was to wait for the final report that can be used for regulatory agency standards.
- Jeremy (WYDEQ) Update Assimilative capacity is driving untreated water discharges. Belle Fourche and Cheyenne are not receiving much produced water anymore. 20 + treated discharges in powder.

- Dave Peterson (USGS) update No sampling in Belle Fouche or Cheyenne in 2008. Other sampling continues Fish, Invertebrates, habitat, algae. A final report is due and in review. Final report should help guide future monitoring.
- Hanna Griscom (WYNDD) update Field work will continue in 2009. Short discussion of tiger salamander deaths in ponds with follow-up needed between WYNDD and WYBLM.
- Hanna and Dave need to discuss sampling at Burger Draw and Salt Creek.
